Missouri Department of Corrections.

# Matthew James Cole

---

- Charged with domestic assault in the 2<sup>nd</sup> degree and was sentenced to 7 years in the Missouri Department of Corrections.



# Michael Lee Sterling

---

- Charged with failure to register as a sex offender and was sentenced to 4 years in the Missouri Department of Corrections.
- In a separate case, defendant was charged with failure to register as a sex offender 3rd offense and was sentenced to 10 years in the Missouri Department of Corrections.



# Justin Ray Downing

- Charged with 5 counts of forgery and was sentenced to 7 years in the Missouri Department of Corrections on each count.
- In a separate case, defendant was charged with Possession of a controlled substance (methamphetamine) and was sentenced to 5 years in the Missouri Department of Corrections.



# Kyle Stephen Fraser

- Charged with possession of a controlled substance (methamphetamine) and unlawful possession of drug paraphernalia. Defendant was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.
- In a separate case, defendant was charged with property damage in the 1<sup>st</sup> degree and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.



# William D Warmann

---

- Charged with driving while intoxicated as a persistent offender and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



# Bennie Jo Jett

---

- Charged with possession of a controlled substance (methamphetamine) and was sentenced to 5 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.
- In a separate case, defendant was charged with Possession of a controlled substance (methamphetamine), endangering the welfare of a child, endangering the welfare of a child, stealing motor vehicle and stealing animal and was sentenced to 10 years in the Missouri Department of Corrections for Count I; as to Count II, 5 years in the Missouri Department of Corrections; as to County III, 5 years in the Missouri Department of Corrections; as to County IV, 2 years in the Missouri Department of Corrections; as to County V, 2 years in the Missouri Department of Corrections.



# Deborah Sue Holloway

---

- Charged with Stealing- controlled substance/meth manufacturing material and was sentenced to 5 years in the Missouri Department of Corrections.
- In a separate case, defendant was charged with Forgery and was sentenced to 5 years in the Missouri Department of Corrections.



# Jennifer Lynn Schanuel

- Charged with possession of a controlled substance (methamphetamine) and was sentenced to 10 years in the Missouri Department of Corrections.
- In a separate case, defendant was charged with Trafficking Drugs 2nd degree (methamphetamine) and was sentenced to 10 years in the Missouri Department of Corrections.



# John William David Rus

- Charged with driving while intoxicated as an aggravated offender and was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



# James Troy Roberts

- Charged with driving while intoxicated as an aggravated offender and was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



# Matthew MacDonald

- Charged with unlawful use of a weapon while intoxicated and was sentenced to 7 years in the Missouri Department of Corrections.



# Christopher Ray Schulze

Charged with harassment in the  
1st degree and was sentenced to  
4 years in the Missouri  
Department of Corrections.



# Augustus Cornellious Sherman

---

Charged with stealing and was sentenced to 5 years in the Missouri Department of Corrections.



# Eric Christopher Opie

- Charged with Possession of a controlled substance (methamphetamine) and delivery of a controlled substance (psilocybin mushrooms). Defendant was sentenced to 7 years in the Missouri Department of Corrections on both counts.



## Richard Lenn Craig

Charged with driving while intoxicated as a persistent offender and was sentenced to 5 years in the Missouri Department of Corrections.



## Daniel Paul Walters

Charged with domestic assault in the 3<sup>rd</sup> degree and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.



## Ernest Junior Barnwell

Charged with driving while intoxicated as a habitual offender and was sentenced to 9 years in the Missouri Department of Corrections.



## Joshua Abel Keil

---

- Charged with aggravated fleeing a stop or detention and was sentenced to 4 years in the Missouri Department of Corrections.



# Ryan Irwin Cairel

- Charged with Possession of a controlled substance and driving while intoxicated as a persistent offender. Defendant was sentenced to 7 years in the Missouri Department of Correction. Execution of sentence suspended with 5 years probation as to count I and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation as to count II.



# Paul J Sayre

- Charged with domestic assault in the 3<sup>rd</sup> degree and was sentenced to 7 years in the Missouri Department of Corrections.



# Cody James Mitchell

---

- Charged with unlawful possession of a firearm and was sentenced to 4 years in the Missouri Department of Corrections.



# Robert Francis Douglas

Charged with aggravated fleeing a stop or detention (count I), possession of a controlled substance (count II, methamphetamine) and property damage 1st degree (count III) and was sentenced to: 7 years in the Missouri Department of Corrections as to Count 1; 9 years in the Missouri Department of Corrections as to Count 2; 7 years in the Missouri Department of Corrections as to Count 3.



# Angel Justina Ryals

- Charged with possession of a controlled substance (methamphetamine) and was sentenced to 4 years in the Department of Corrections.
