Missouri Department of Corrections.

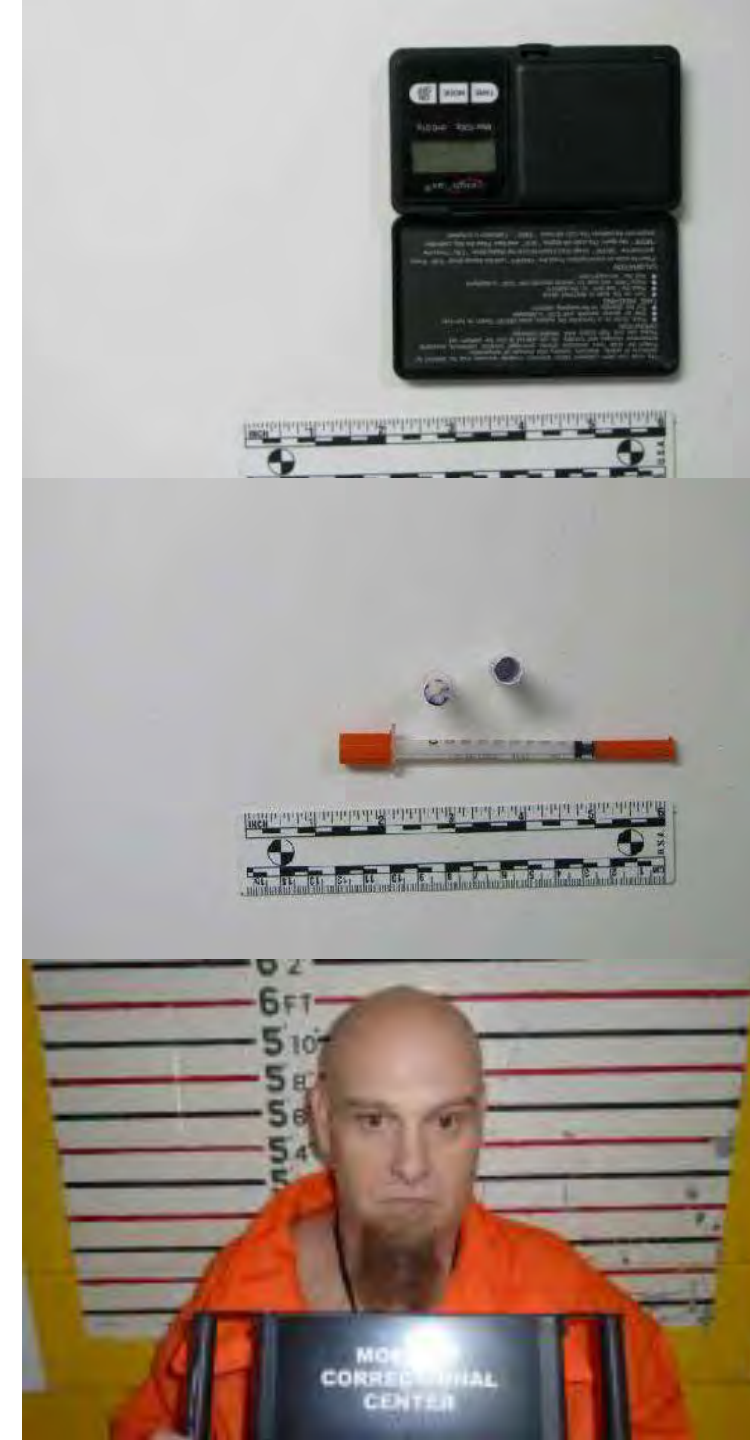
Coleman Ray Brown

- Charged with Possession Of Controlled Substance (cocaine). After violating the terms and conditions of his probation he was sentenced to 7 years in the Missouri Department of Corrections.



Joseph Lee Madison Blecher

- Charged with Possession of a Controlled Substance (Count I, methamphetamine) and Driving While Revoked/suspended - 2nd Or Subsequent Offense (Count II). As to Count I, defendant was sentenced to 3 years in the Missouri Department of Corrections. Execution of sentence was suspended with 5 years supervised probation. As to Count II, defendant was sentenced to 90 days in the Camden County Adult Detention Center.
- In a separate case Joseph Lee Madison Blecher was charged with Assault in the 2nd degree (Count I) and Tampering with a motor vehicle 1st degree. (Count II). Defendant was sentenced to 7 years in the Missouri Department of Corrections on each count. Execution of sentence was suspended with 5 years supervised probation.



Shannon Nicole Russell

- Charged with Possession of a controlled substance (methamphetamine). After violating the terms and conditions of her probation she was sentenced to 4 years in the Missouri Department of Corrections.



Gino Orlando Johnson

- Charged with 3 Counts of Possession of a Controlled Substance (methamphetamine, fentanyl and psilocybin mushrooms). After violating the terms and conditions of his probation, he was sentenced to 10 years in the Missouri Department of Corrections on each Count.
- In a separate case Gino Orland Johnson was charged with Possession of a controlled substance (methamphetamine). He was sentenced to 10 years in the Missouri Department of Corrections.



Rudolph James Witte Jr.

- Charged with Driving while intoxicated as an aggravated offender. After violating the terms and conditions of his probation, he was sentenced to 7 years in the Missouri Department of Corrections.



Kenneth Outley

- Charged with Stealing Leased Or Rented Property and was sentenced to 8 years in the Missouri Department of Corrections. Execution of sentence was suspended with 5 years supervised probation.



Jaimee Michelle Dixon

- Charged with Possession of a controlled substance (methamphetamine). After violating conditions of probation, probation was revoked and she was sentenced to 2 years in the Missouri Department of Corrections.



Kenneth Charles Jones

- Charged with Possession of a controlled substance (methamphetamine). After violating the terms and conditions of his probation, he was sentenced to 7 years in the Missouri Department of Corrections.



Jeannie May Garmany

- Charged with Possession of a controlled substance (methamphetamine) and was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence was suspended with 5 years supervised probation.



De'Aaron Derrick Knowles

- Charged with Kidnapping - 2nd Degree (Count I), Domestic Assault in the 2nd Degree (Count II), Assault - 3rd Degree (Count III) and Harassment - 1st Degree (Count IV). As to Count I and II, defendant was sentenced to 7 years in the Missouri Department of Corrections. As to Count III and IV, defendant was sentenced to 4 years in the Missouri Department of Correction. Execution of sentence was suspended with 5 years supervised probation.



Nigel Scott Howard

- Charged with Possession of a Controlled Substance – prior offense (methamphetamine). After violating the terms and conditions of his probation, he was sentenced to 9 years in the Missouri Department of Corrections.



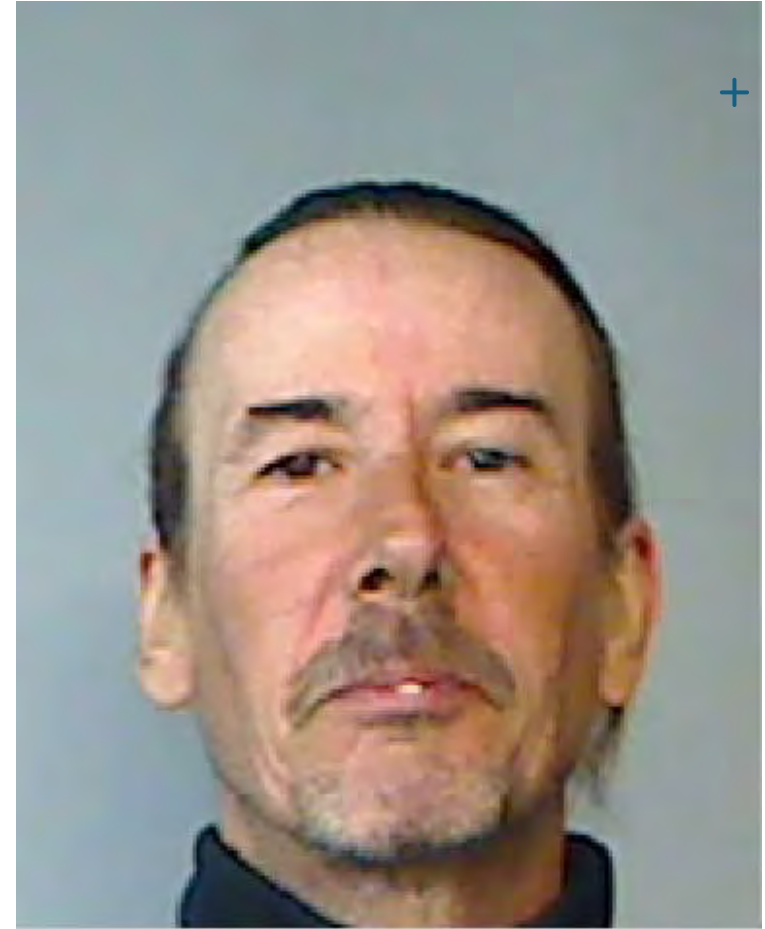
Joseph Nathaniel Bess

- Charged with Possession of a controlled substance (Count I, methamphetamine) and DWI – Persistent (Count II). Defendant was sentenced to 4 years in the Missouri Department of Corrections for each count. Execution of sentence was suspended with 5 years supervised probation.



James Rudolph Witte

- Charged with Driving while suspended or revoked and was sentenced to 4 years in the Missouri Department of Corrections after violating Conditions of Probation.



Jerry Wayne Harrington Jr

- Charged with Driving while intoxicated as a persistent offender and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence was suspended with 5 years supervised probation.



Austin Carl Blake

- Charged with Sex Offender Physically Present/loiter Within 500 Feet Of Park W/ Playground/pool/museum - 1st Offense and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence was suspended with 5 years supervised probation.



Sara Lee

- Charged with Possession of a controlled substance (methamphetamine). After violating the terms and conditions of her probation, she was sentenced to 4 years in the Missouri Department of Corrections.



Dayton Lee Bertoncino

- Charged with Domestic Assault in the 1st degree with no serious physical injury and was sentenced to 10 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



Bobby Gene Childers

- Charged with BWI- death of another (Count I), BWI- serious injury (Count II) and was sentenced to 10 years in the Missouri Department of Corrections on Count I and 7 years in the Missouri Department of Corrections on Count II.



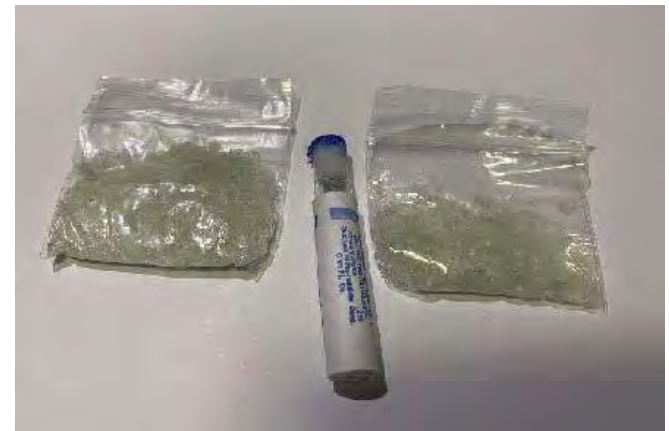
Travis Eugene Crown

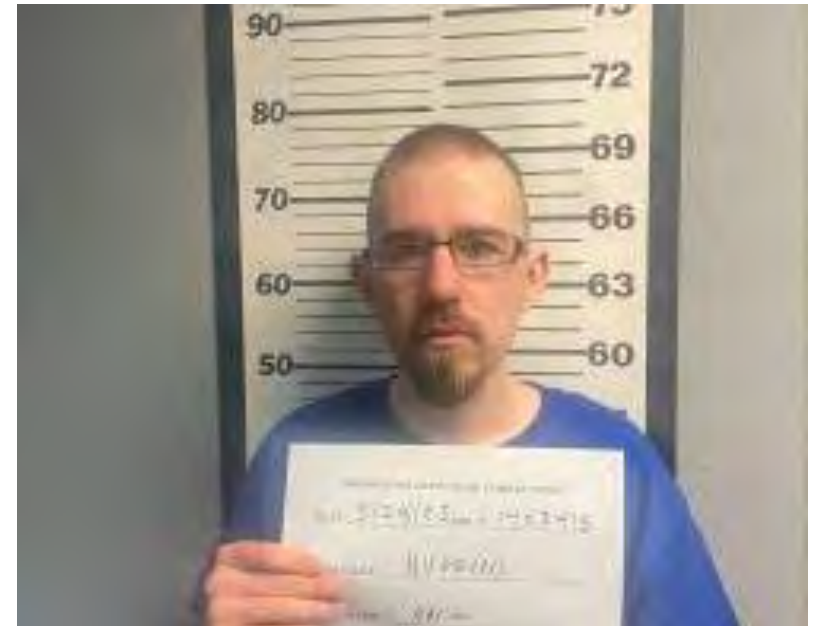
Ashley Marie Elkins

- Charged with Delivery of a controlled substance (Count I, methamphetamine) and Delivery Or Possession Of A Controlled Substance At County/Private Jail/Correctional Center (Count II) and was sentenced to 7 years in the Missouri Department of Corrections on each Count.

- Charged with Harassment in the 1st degree and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence was suspended with 5 years supervised probation.



Stephanie Rose Onak-Keller

- Charged with Tampering with motor vehicle in the 1st degree and was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence was suspended with 5 years supervised probation.



Mark Anthony Kirk

- Charged with Possession of a controlled substance (methamphetamine). He was sentenced to 7 years in the Missouri Department of Corrections.



Justin Lonnie Bartels

- Charged with Aggravated fleeing a stop or detention. He was sentenced to 10 years in the Missouri Department of Corrections.

- Charged with Driving while intoxicated as a persistent offender and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence was suspended with 5 years supervised probation.



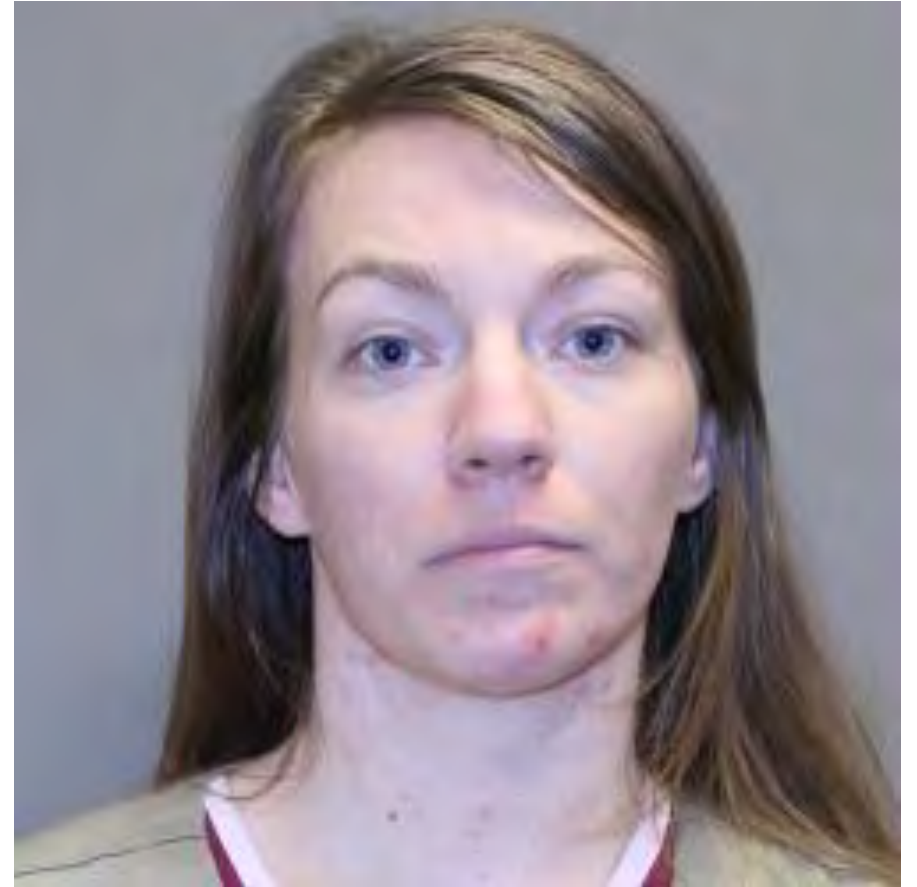
Joyce Ruth Lindecamp
