- Charged with Domestic Assault in the 2nd degree and Domestic Assault in the 3rd degree. After defendant violated terms and conditions of probation, he was sentenced to 5 years in the Missouri Department of Corrections on each Count.

- Charged with Possession of a controlled substance (methamphetamine). After violating conditions of probation, defendant was sentenced to 7 years in the Missouri Department of Corrections.

- Charged with Possession of a controlled substance (methamphetamine). After defendant violated terms and conditions of probation, she was sentenced to 7 years in the Missouri Department of Corrections.

- Charged with Possession of a controlled substance (methamphetamine) was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence was suspended with 5 years supervised probation.

- Charged with Possession of a Control Substance (methamphetamine). After defendant violated terms and conditions of probation, he was sentenced to 8 years in the Missouri Department of Corrections.

- Charged with two Counts of Sexual Misconduct Or Attempt Involving A Child Less Than 15 Years Of Age - 1st Offense and was sentenced to 4 years in the Missouri Department of Corrections on each Count, Consecutive.

- Charged with Driving while intoxicated as an aggravated offender and was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence was suspended with 5 years supervised probation.

- Charged with Possession of a controlled substance (methamphetamine) and was sentenced to 2 years in the Missouri Department of Corrections.



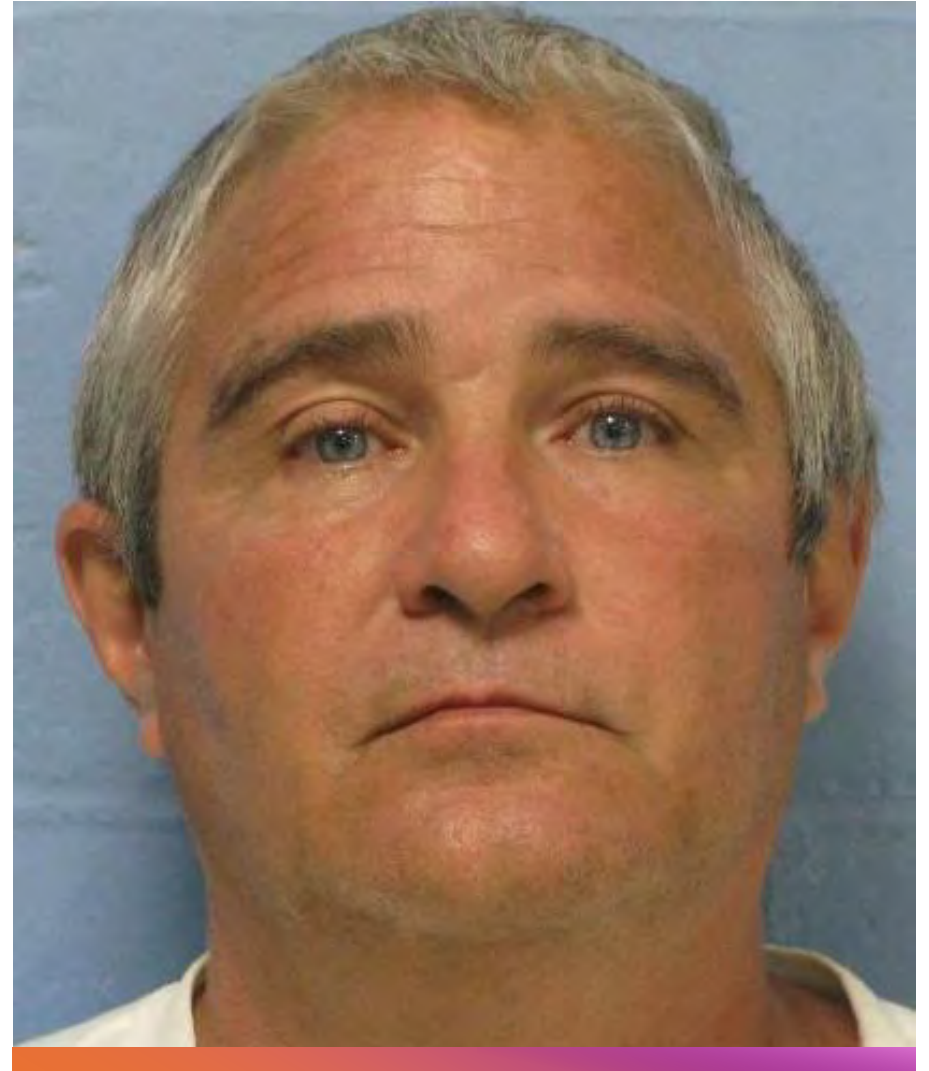
Christopher Neil Hyde

- Charged with Violating a condition of lifetime supervision and was sentenced to 3 years in the Missouri Department of Corrections





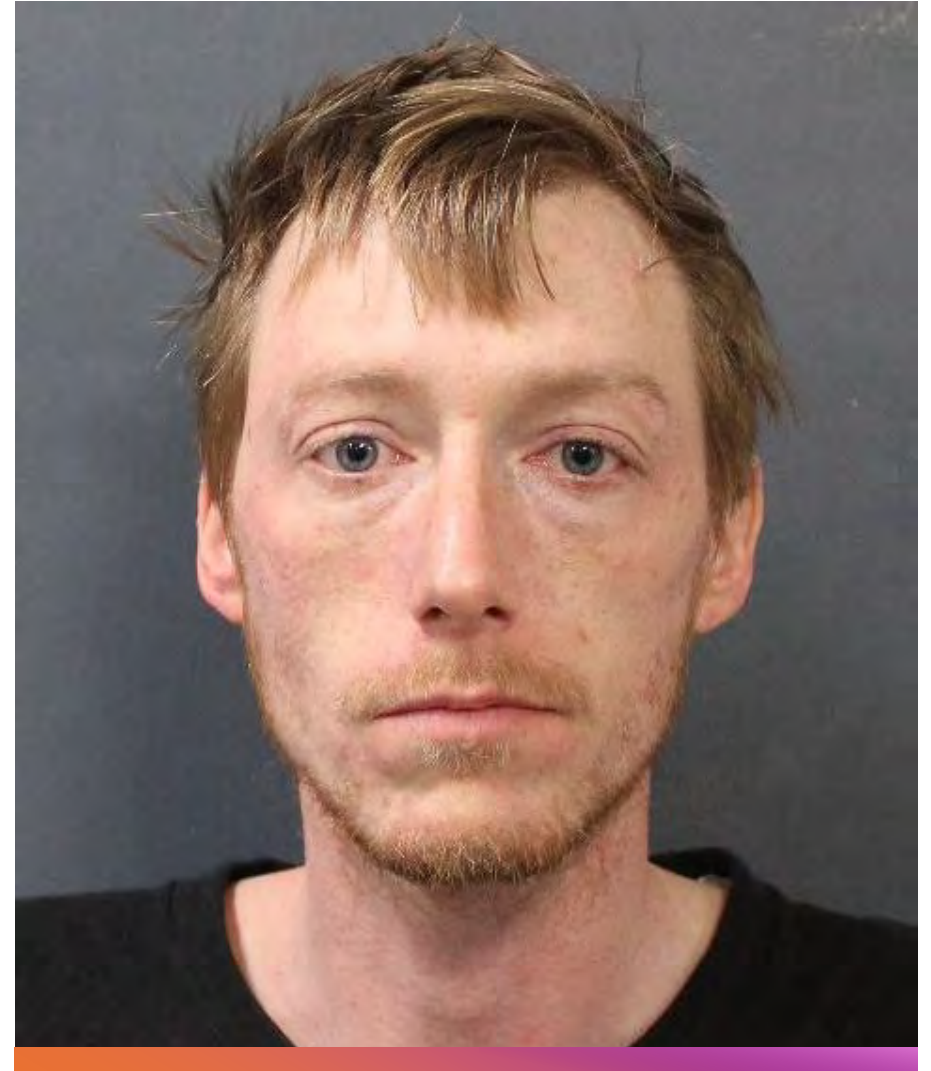
Amber Dawn Bishop

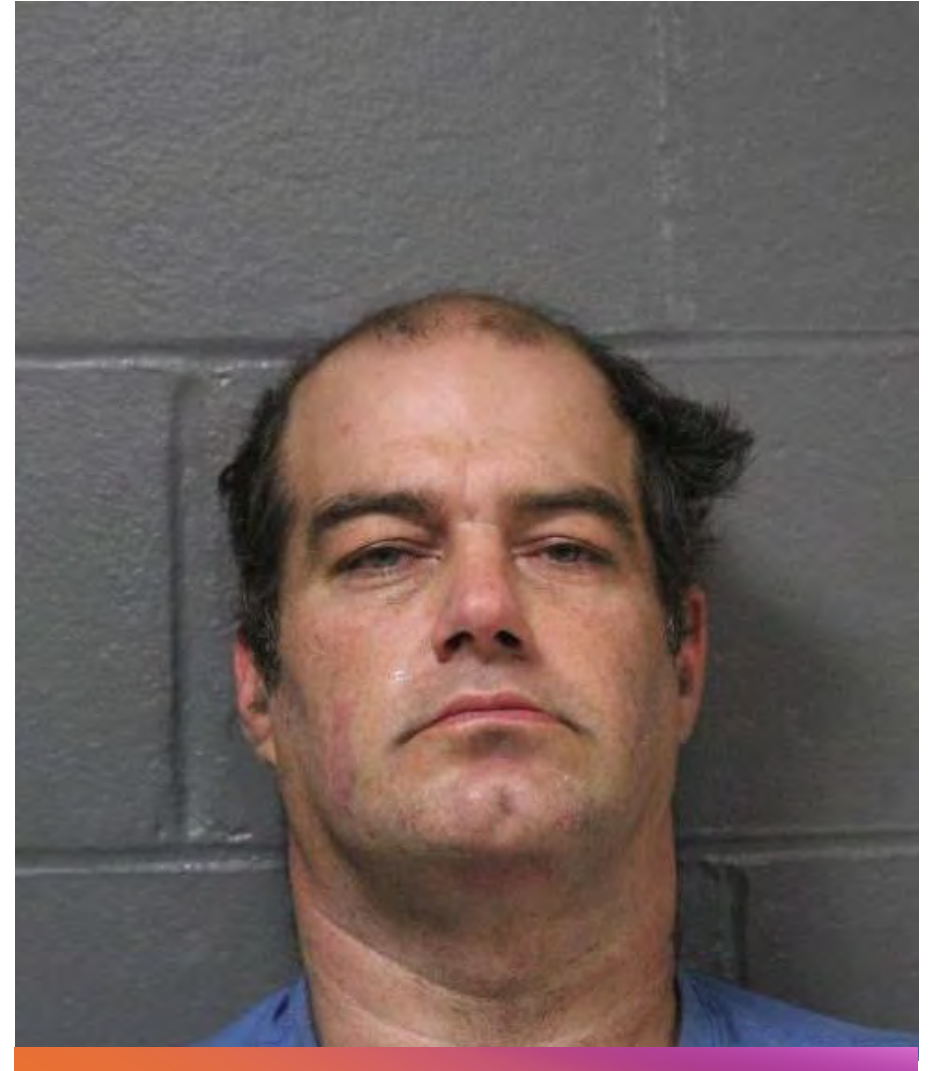
Jesse James Balocca

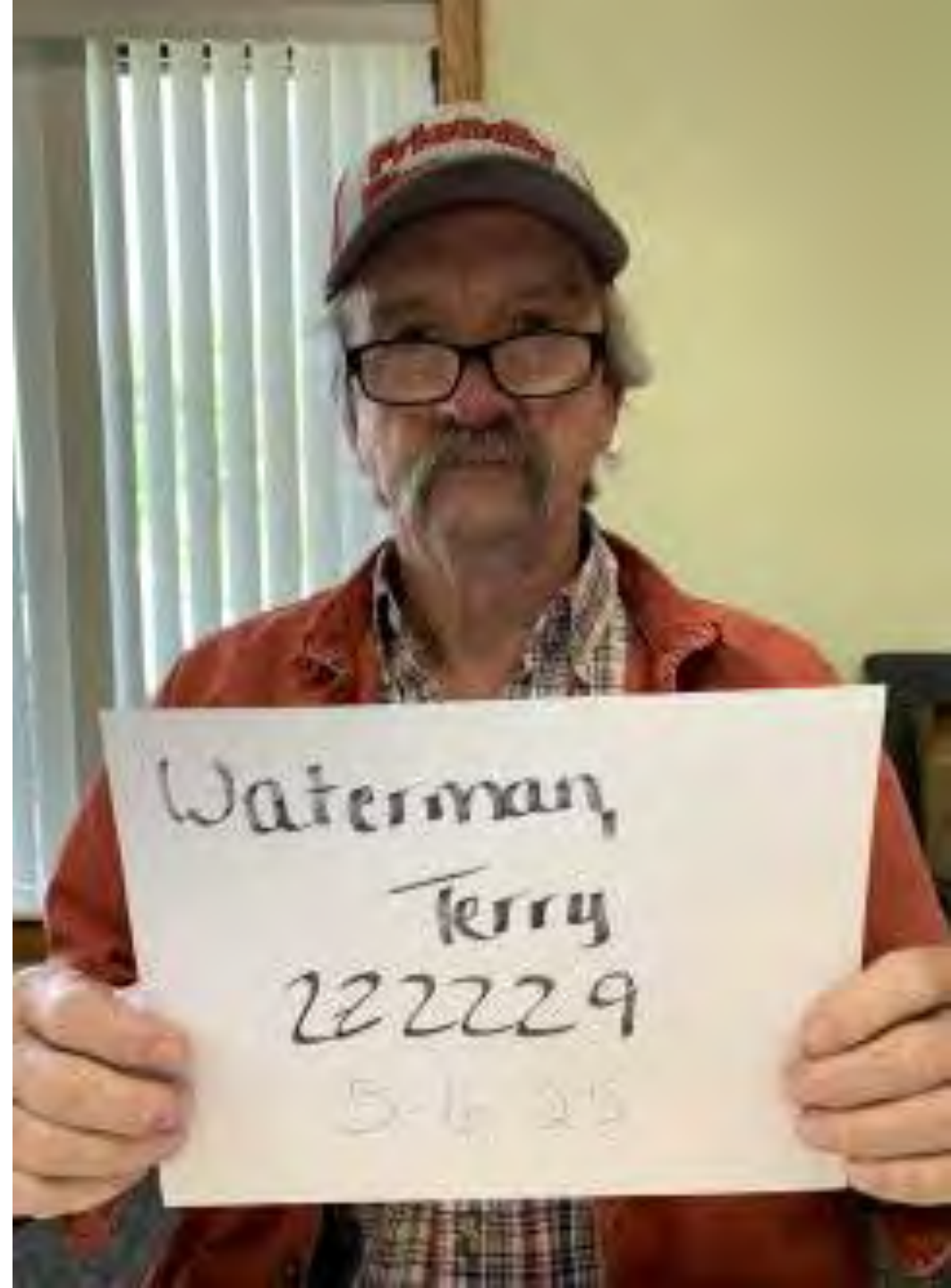
Jenna Marie Becker
