- Charged with Possession of a Controlled Substance (methamphetamine) and was sentenced to 7 years in the Missouri Department of Corrections.

- Charged with possession of a controlled substance (cocaine and methamphetamine) and was sentenced to 7 years in the Missouri Department of Corrections.



Cory Pierce

- Charged with Possession of a controlled substance (methamphetamine) and was sentenced to 2 years in the Missouri Department of Corrections.



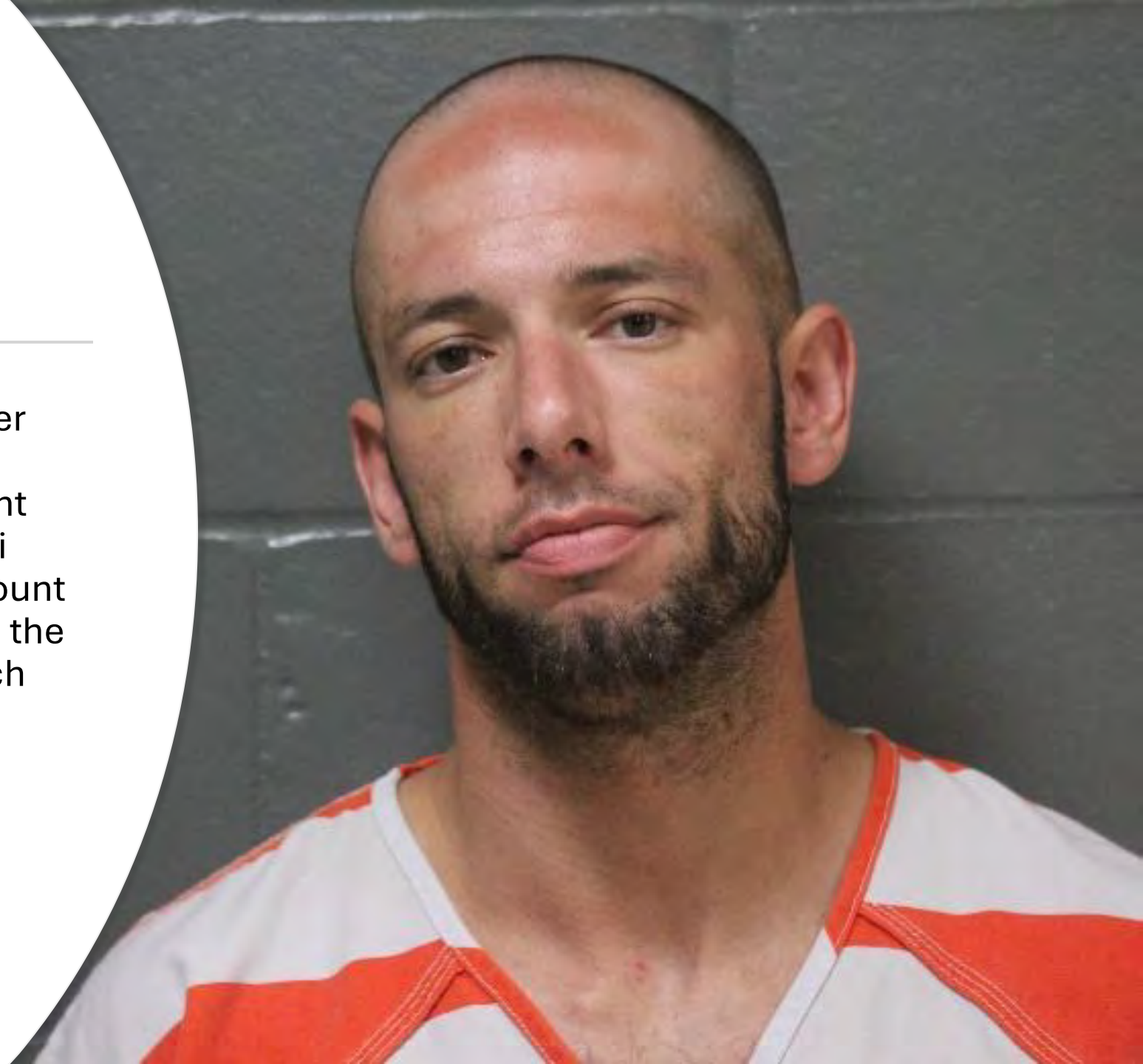
Casey Joann Martin

- Charged with Possession of a Controlled Substance (methamphetamine) and was sentenced to 10 years in the Missouri Department of Corrections.



Jordan Fitzgerald Jones

- Charged with Involuntary manslaughter 1st degree (Count I) and armed criminal action (Count II). As to Count I, defendant was sentenced to 7 years in the Missouri Department of Corrections and as to Count II defendant was sentenced to 8 years in the Missouri Department of Corrections each count to run consecutive to the other.



Willie Jacob Box

- Charged with Driving while intoxicated as an aggravated offender and was sentenced to 10 years in the Missouri Department of Corrections.



Tristen L Green

- Charged with unlawful possession of a weapon and was sentenced to 3 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.



Ernest Andrew Blair Sr.

- Charged with Possession of a controlled substance (methamphetamine) and was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



Joshua Dale Bishop

- Charged with unlawful use of a weapon and possession of a controlled substance (methamphetamine) defendant was sentenced to 4 years in the Missouri Department of Corrections on both counts. Execution of sentence suspended with 5 years supervised probation.



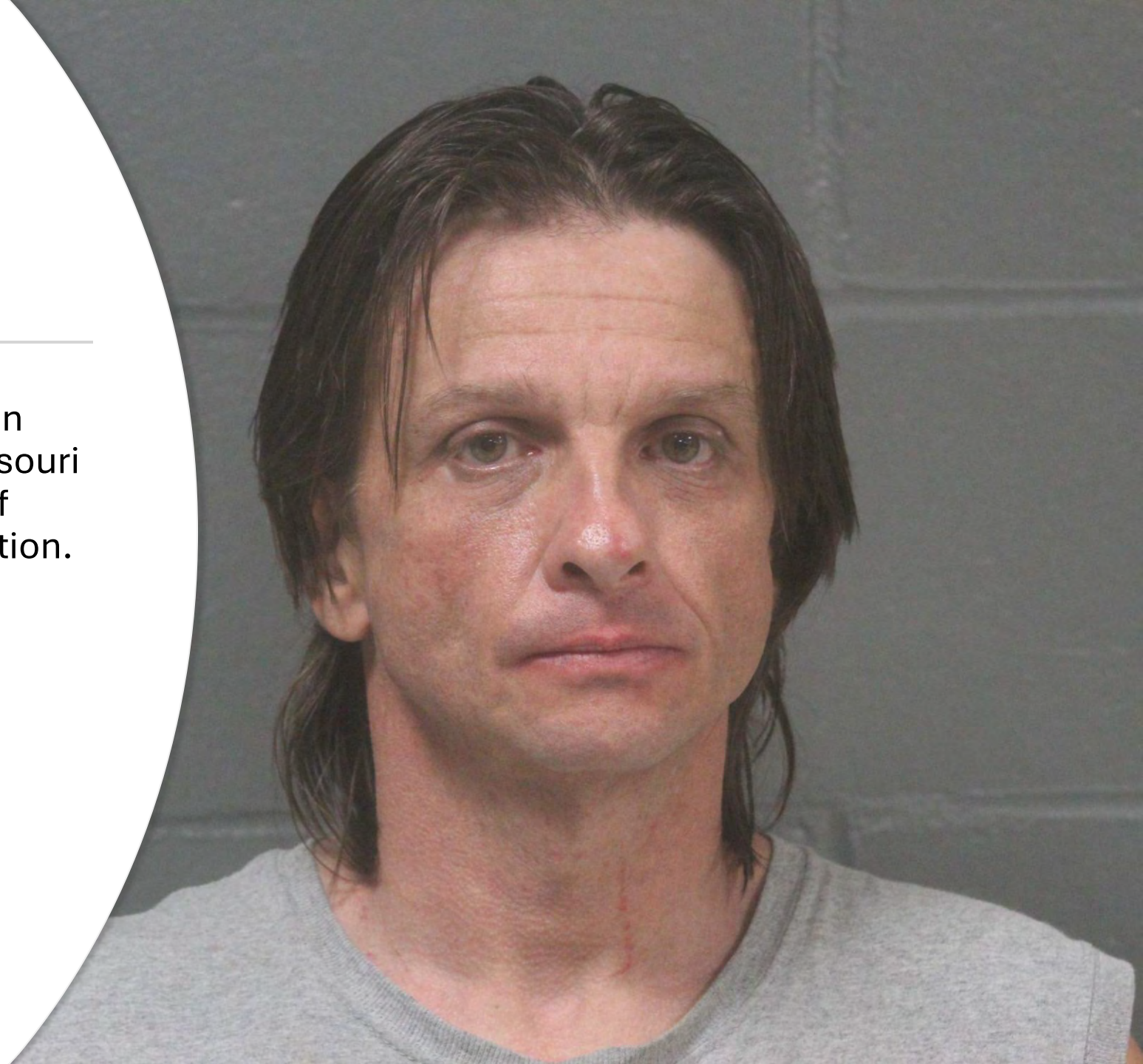
Quantez Lamar Griffin

- Charged with Domestic Assault in the 2nd degree and was sentenced to 7 years in the Missouri Department of Corrections.

- Charged with unlawful use of a weapon and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.

- Charged with failure to register and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.



Justin John Marshall

- Charged with domestic assault in the 1st degree (Count I), endangering the welfare of a child in the 1st degree (Count II) and endangering the welfare of a child in the 1st degree (Count III). As to Count I, defendant was sentenced to 15 years in the Missouri Department of Corrections, as to Count II and III sentenced to 7 years in the Missouri department of Corrections. Execution of sentence suspended with 5 years probation.



Devin Tyler Koski

- Charged with Possession of a controlled substance (methamphetamine) and was sentenced to 4 years in the Missouri Department of Corrections.



Christopher Ricky Alen Wilson

Charged with stealing \$750.00 or more and was sentenced to 5 years in the Missouri Department of Corrections.



Richard Alfred Metz

- Charged with two counts of delivery a controlled substance (cocaine and methamphetamine) and was sentenced to 10 years in the Missouri Department of Corrections on each count. Execution of sentence suspended with 5 years supervised probation.



Bary Lynn Weems

- Charged with possession of a controlled substance (methamphetamine) and was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence suspended and 5 years supervised probation.



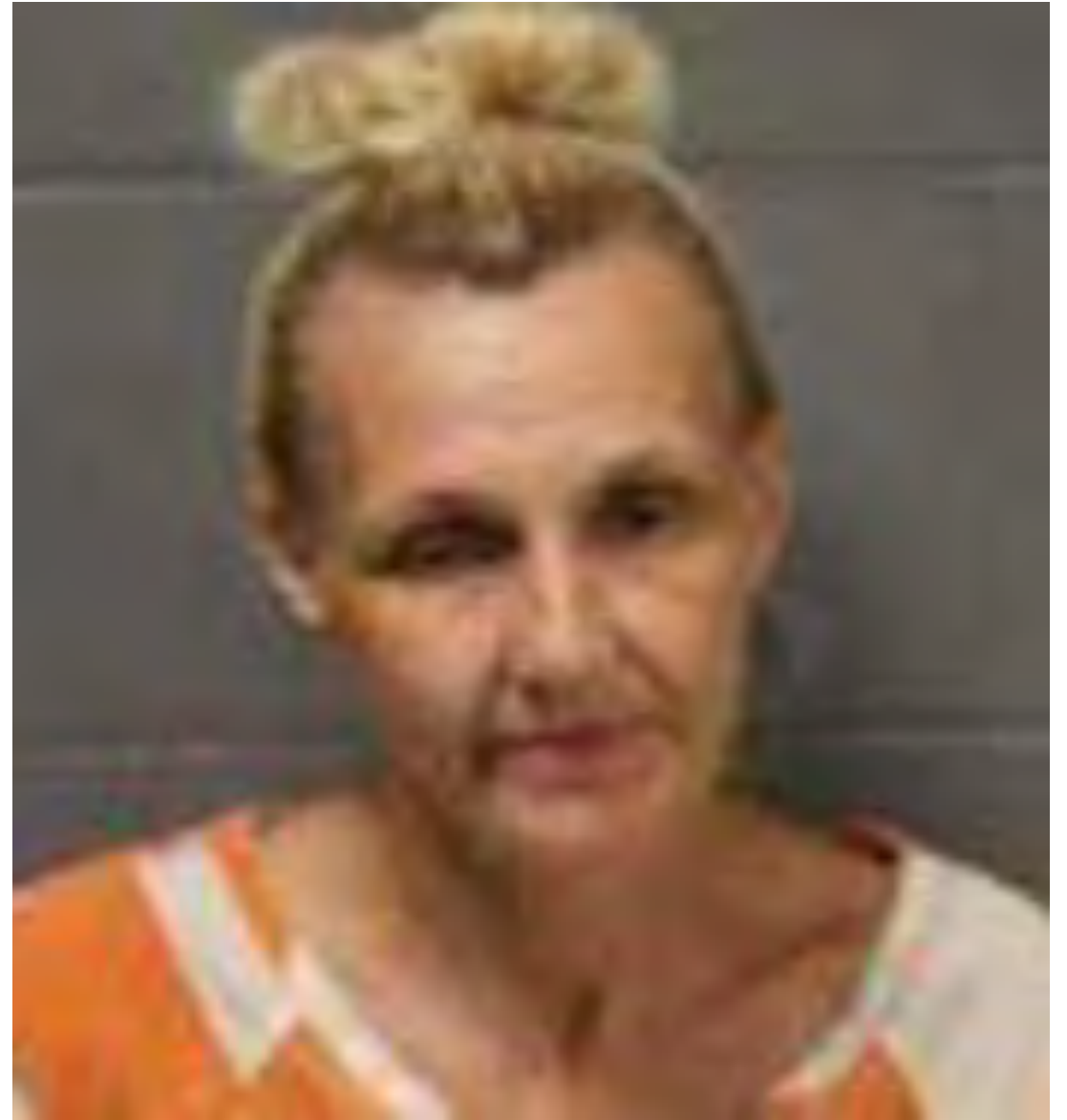
Justin Hagar Dean

As to Count I, defendant was sentenced to 7 years in the Missouri Department of Correction, 4 years as to Count II and 120 days in Jail as to Count III.



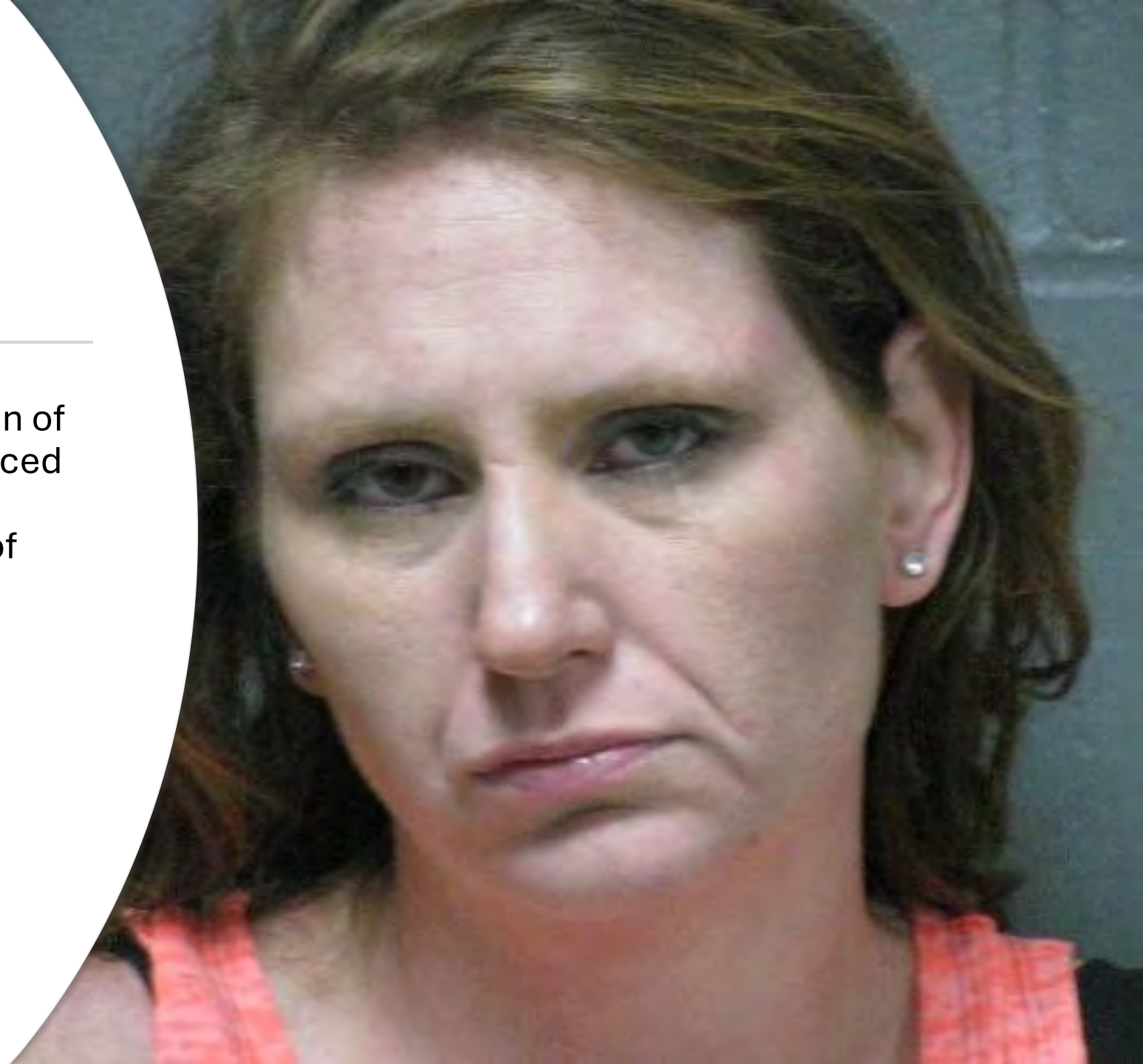
Machelle Dawn Fields

- Charged with possession of a controlled substance (methamphetamine) and was sentenced to 4 years in the Missouri Department of Correction. Execution of sentence suspended with 5 years supervised probation.

- Charged with two counts of Possession of a Controlled Substance and was sentenced to 4 years in the Missouri Department of Corrections on both counts. Execution of sentence suspended with 5 years of supervised probation.
