20 defendants sentenced to the
Missouri Department of Corrections.

Christopher Cole Thomas

- Charged with Forgery and was sentenced to 4 years in the Missouri Department of Corrections.
- In a separate case Cole Thomas was charged with aggravated fleeing to stop or detention and was sentenced to 5 years in the Missouri Department of Corrections.



Michael Krisgen Barker

- Charged with Domestic Assault 2nd degree and was sentenced to 10 years in the Missouri Department of Corrections.



John Blake Skinner

- Charged with stealing \$750.00 or more and was sentenced to 3 years in the Missouri Department of Corrections
- In a separate case, defendant was charged with possession of a controlled substance (methamphetamine). He was sentenced to 5 years in the Missouri Department of Corrections.



Bryan Joseph Dennis

- Charged with resisting arrest and operating a motor vehicle on highway without a valid license and was sentenced to 5 years probation. Execution of sentence suspended with 5 years probation.

- Charged with Possession of a controlled substance (methamphetamine) and unlawful possession of a firearm. Defendant was sentenced to 7 years in the Missouri Department of Corrections as to Count I and sentenced to 5 years in the Missouri Department of Corrections as to Count II.
- In a separate case, defendant charged with harassment in the 1st degree. He was sentenced to 5 years in the Missouri Department of Corrections.



Jason Michael Hill

- Charged with driving while intoxicated and causing physical injury to another and was sentenced to 2 years in the Missouri Department of Corrections.
- In a separate case, defendant was charged with leaving the scene of an accident and no operator license. defendant was sentenced to 7 years in the Missouri Department of Corrections as to Count I and 1 year in the Missouri Department of Corrections on Count II.



Mark Alexander French

- Charged with Stealing- motor vehicle and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.



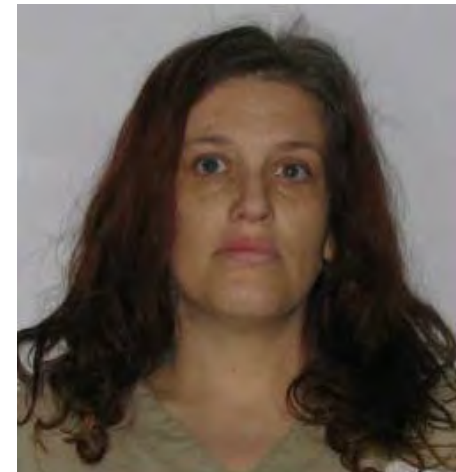
Timothy Verode Green Jr

- Charged with Possession of a controlled substance (Fentanyl), Possession of a controlled substance (Cocaine) and unlawful use of weapon and was sentenced to 4 years in the Missouri Department of Corrections as to count I, 4 years in the Missouri Department of Corrections as to Count II and 2 years in the Missouri Department of Corrections as to Count III. Execution of sentence suspended with 5 years probation on all counts.



Crystal M Latiker

- Charged with Delivery or possession of a controlled substance at County/Private Jail/Correction center (methamphetamine) and was sentenced to 5 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.



Cori Ann Meglan

- Charged with driving while intoxicated and physical injury to another and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



John Charles Harris

- Charged with driving while intoxicated as a persistent offender and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.
