21 Defendants sentenced to the
Missouri Department of Corrections

Paden Douglas Smith

- Charged with Possession of a controlled substance (Count I, Methamphetamine) and unlawful possession of a firearm (Count II). As to each Count, defendant was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



Wesley David Salamun

- Charged with Tampering with motor vehicle 1st degree and was sentenced to 10 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.
- In a separate case Wesley David Salamun was charged with Burglary in the 2nd degree. He was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.
- In a separate case Wesley David Salamun was charged with Possession of a controlled substance (clonazepam). He was sentenced to 5 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



Terry A Dickens

- Charged with Tampering with Motor Vehicle (Count I and II) and Resisting arrest (Count III). After violating terms and conditions of probation, defendant was sentenced to 10 years Count I and II and as to Count III, he was sentenced to 4 years in the Missouri Department of Corrections.
- In a separate case Terry A Dickens was charged with Stealing. After violating terms and conditions sentenced to 10 years in the Missouri Department of Corrections.



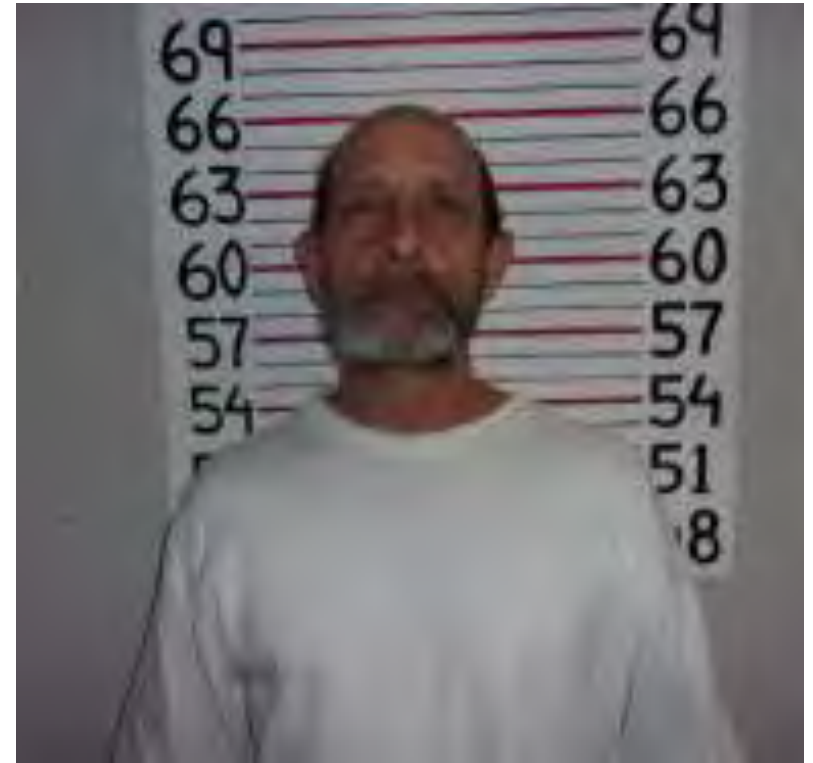
Thomas Shawn Hock

- Charged with Possession of a controlled substance (methamphetamine) and was sentenced to 5 years in the Missouri Department of Corrections.

- Charged with unlawful use of weapon. He was sentenced to 3 years in the Missouri Department of Corrections.

- Charged with Possession of a controlled substance (methamphetamine). He was sentenced to 215 days in the County Jail.

- Charged with Stalking in the 1st degree. He was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.



Amber Renee Prince

- Charged with Resisting Arrest/detention/stop By Fleeing - Creating A Substantial Risk Of Serious Injury/death To Any Person and was sentenced to 2 years in the Missouri Department of Corrections.
- In a separate case Amber Renee Prince was charged with Resisting/interfering with arrest for a felony and was sentenced to 2 years in the Missouri Department of Corrections.



Jennifer J Wilson

- Charged with Possession of a controlled substance (methamphetamine) and was sentenced to 3 years in the Missouri Department of Corrections.



Adam Blake Stutesman

- Charged with Driving while intoxicated as an aggravated offender and was sentenced to 10 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



Ryan Anthony Pierce

- Charged with Assault in the 2nd degree (Count I), Assault in the 2nd degree (Count II), Resisting Arrest/detention/stop By Fleeing - Creating A Substantial Risk Of Serious Injury/death To Any Person (III). As to Count I and Count II was sentenced to 8 years in the Missouri Department of Corrections. As to Count III, defendant was sentenced to 4 years in the Missouri Department of Corrections.

- Charged with Tampering with motor vehicle 1st degree and was sentenced to 10 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years probation.



Brandon Earl Mixon

- Charged with Possession of a controlled substance. After defendant violated terms and conditions of probation, he was sentenced to 7 years in the Missouri Department of Corrections.

- In a separate case Jessica S Lillard was charged with Driving while suspended or revoked and was sentenced to 3 years in the Missouri Department of Corrections.



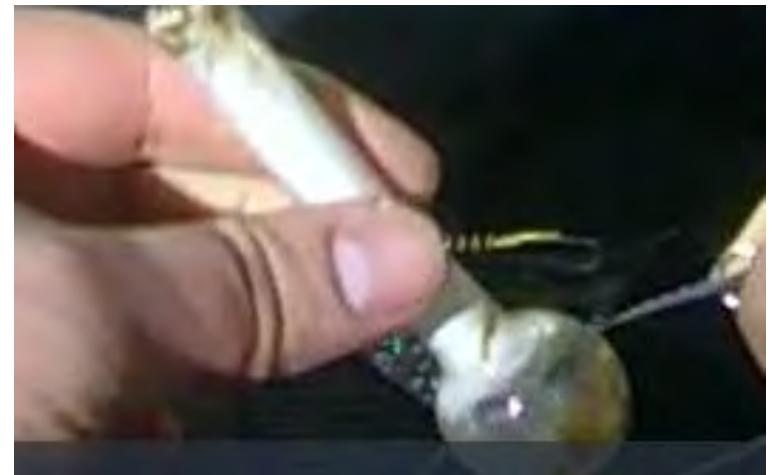
Nigel Scott Howard
