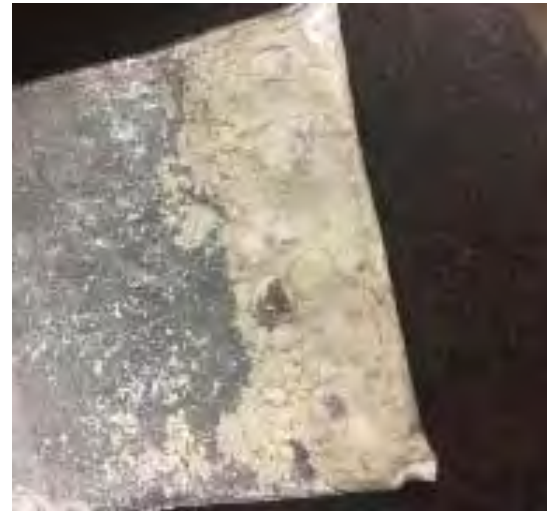


Felony Convictions January 2025

- Charged with Possession of a controlled substance (methamphetamine). After defendant violated probation, he was sentenced to 6 years in the Missouri Department of Corrections.

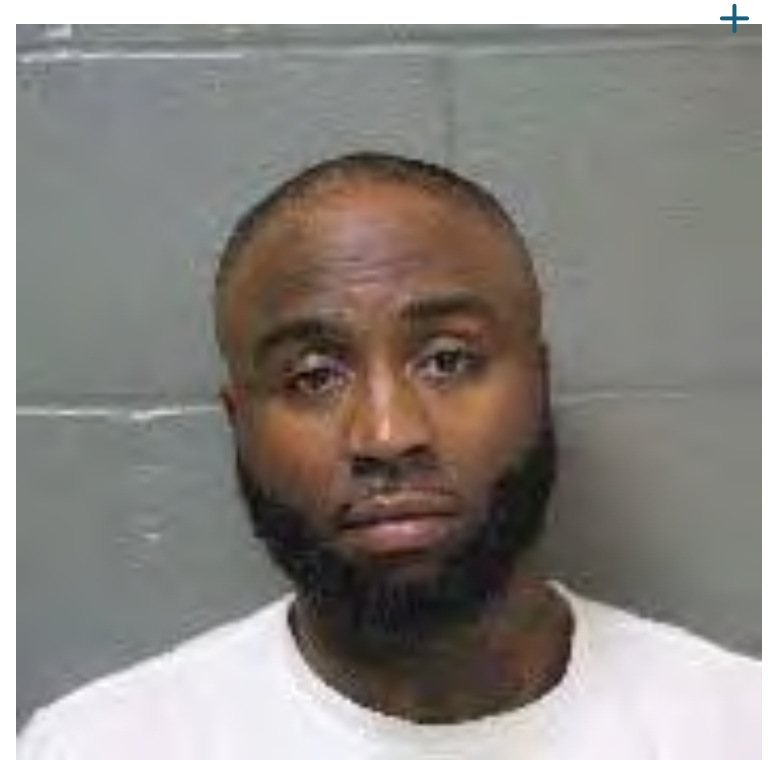

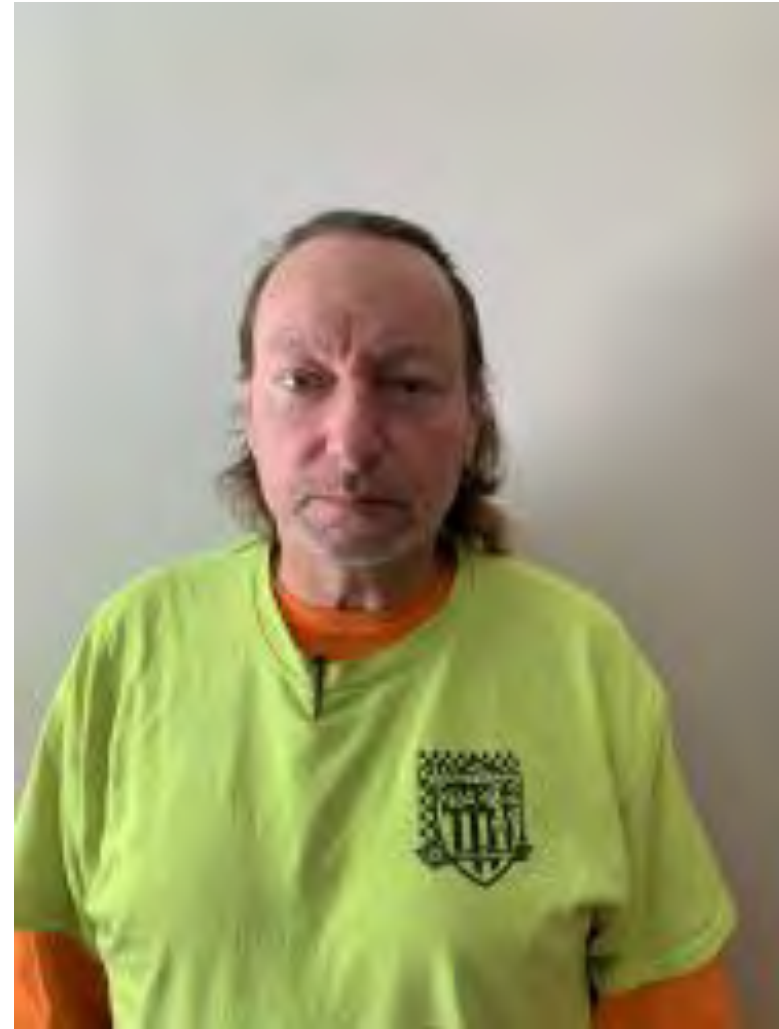
Jasper Scott Smith

- Charged with Possession of a controlled substance (methamphetamine) and was sentenced with \$10,000.00 fine and Court Costs.



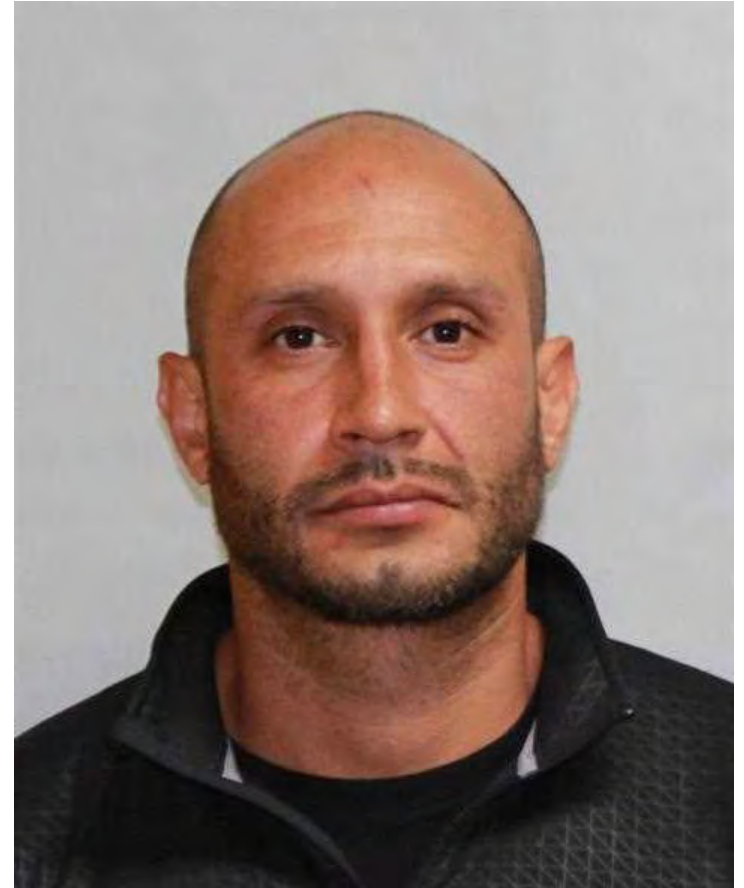
Scott Anthony Davis

- Charged with Possession of a controlled substance (Fentanyl) and was sentenced to 10 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.

- Charged with Domestic Assault in the 2nd degree, kidnapping 2nd degree, endangering the welfare of a child creating substantial risk 1st degree, domestic assault in the 2nd degree and endangering the welfare of a child creating substantial risk 1st degree.
- He was sentenced to 10 years in the Missouri Department of Corrections on each count.



Holly Amber Miller

- Charged with Forgery and was sentenced to 5 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



Christopher Paul Whittle

- Charged with Possession of a controlled substance (methamphetamine) and was sentenced to 10 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



Lucas Drauyn Cornwell

- Charged with Domestic assault in the 3rd degree and was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



Ricky Jay Boutch

- Charged with Possession of a controlled substance (methamphetamine) and was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.

As to Count I, defendant was sentenced to 8 years, as to Count II defendant was sentenced to 4 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.

- Charged with Failure to Register- 1st offense and was sentenced to 4 years in the Missouri Department of Corrections. Suspended execution of sentence 5 years supervised probation.



Travis Lee Pogue

- Charged with Driving while intoxicated as an aggravated offender and was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.



Brandon Lee Combs

- Charged with Possession of a controlled substance (methamphetamine) and resist arrest/detention/ stop by fleeing and was sentenced to 5 years in the Missouri Department of Corrections on each count. Execution of sentence suspended with 5 years supervised probation.



Dustin Chase Alex McCrary

- Charged with Tampering with motor vehicle-1st offense. Defendant was sentenced to 10 years in the Missouri Department of Corrections.



Cody James Bax

- Charged with Driving while intoxicated as a persistent offender and was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.

- Charged with Possession of a controlled substance (methamphetamine) and was sentenced to 7 years in the Missouri Department of Corrections. Execution of sentence suspended with 5 years supervised probation.
