---

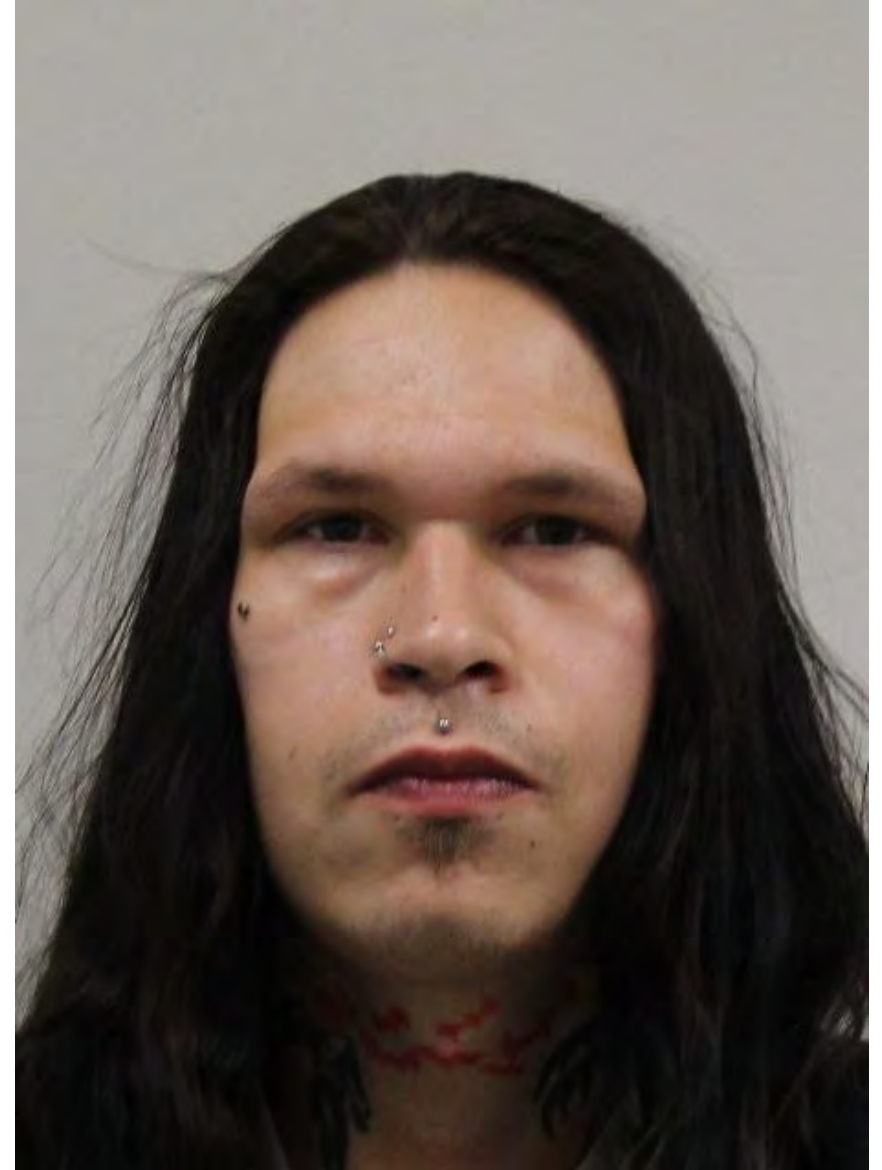

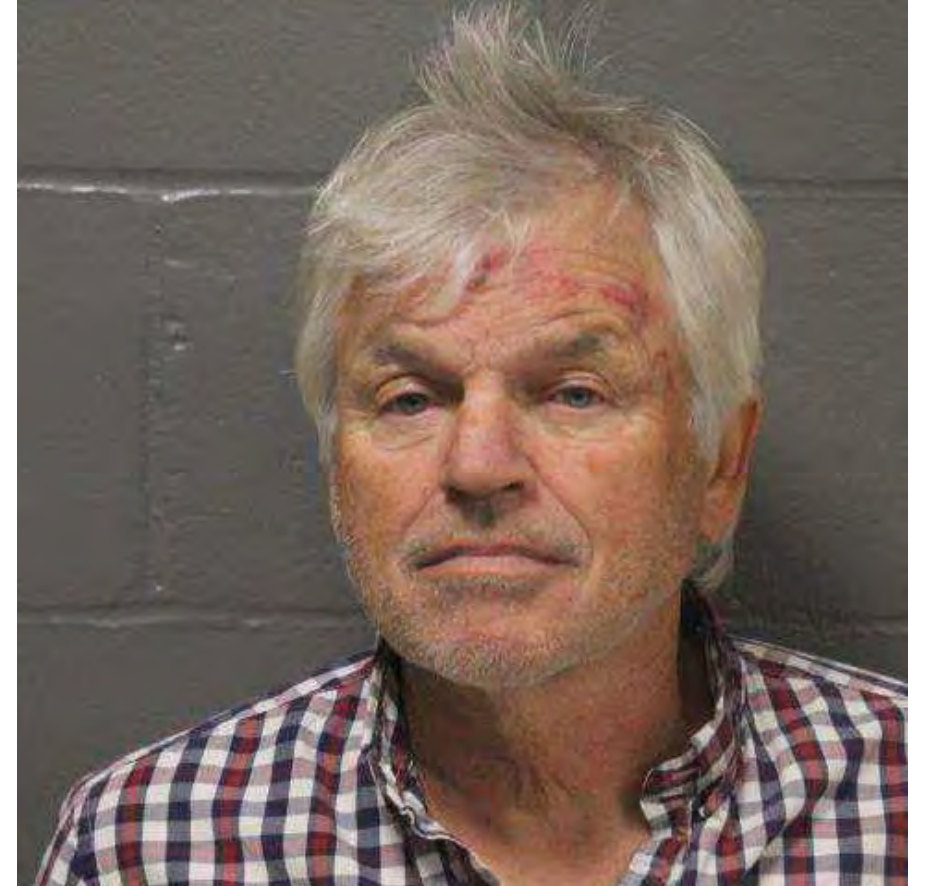

---

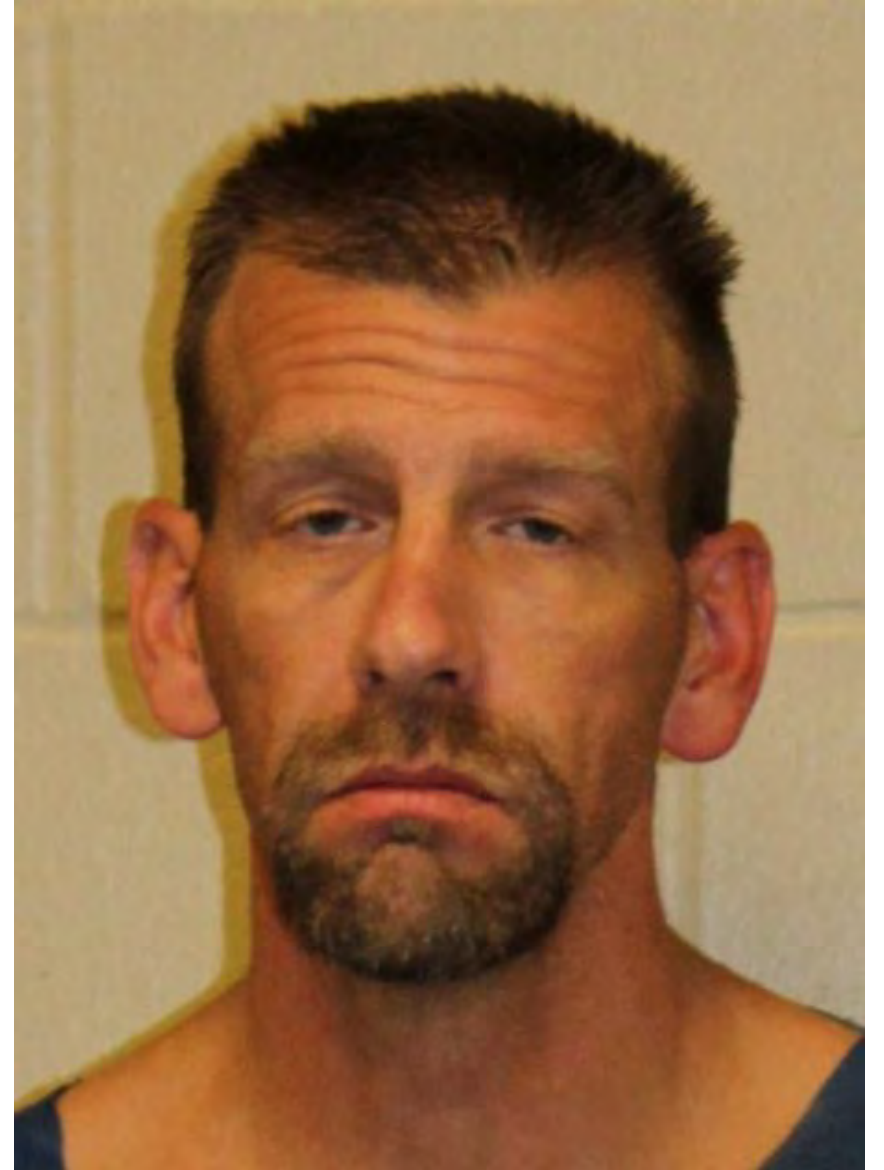
